


# Deadline Approaching - Action Required!

As you are aware there is now a new specification for functional skills which means the legacy qualification must come to an end. Due to COVID-19 they have now moved the last date of exams to December 2019. This means that all learners who are currently registered for the legacy functional skills will need to take and pass their exam before **December 31<sup>st</sup> 2020**.

If the learner does not complete and pass the qualification then they will need to be registered on the new qualification.
